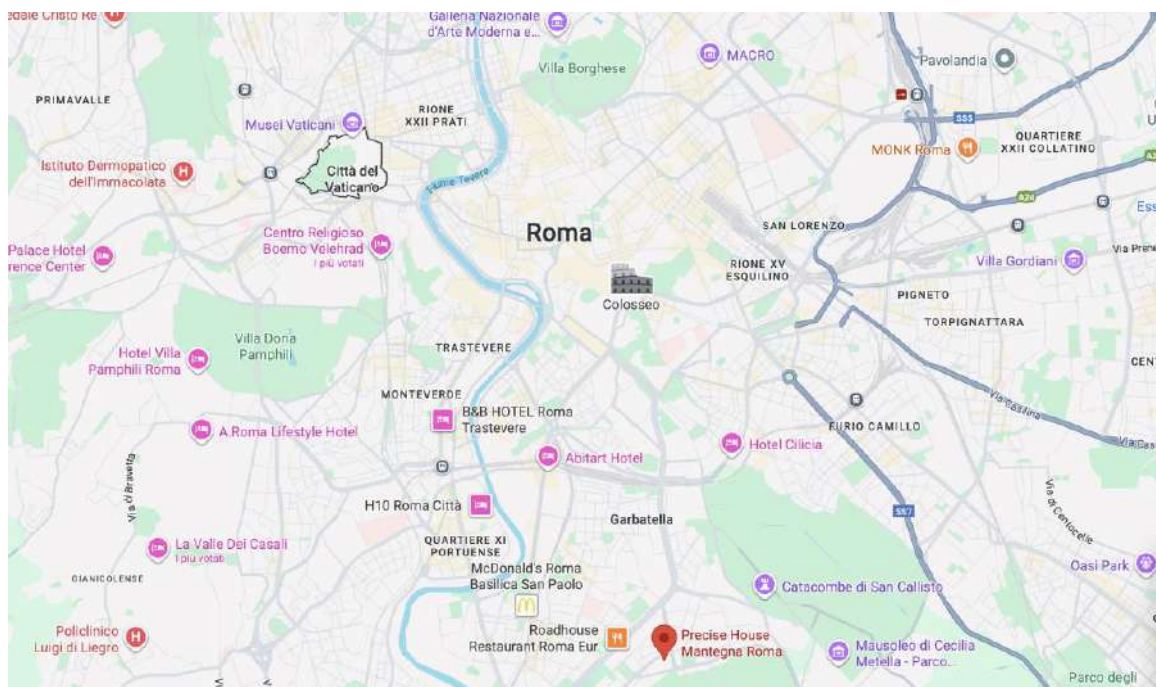


### How to get there

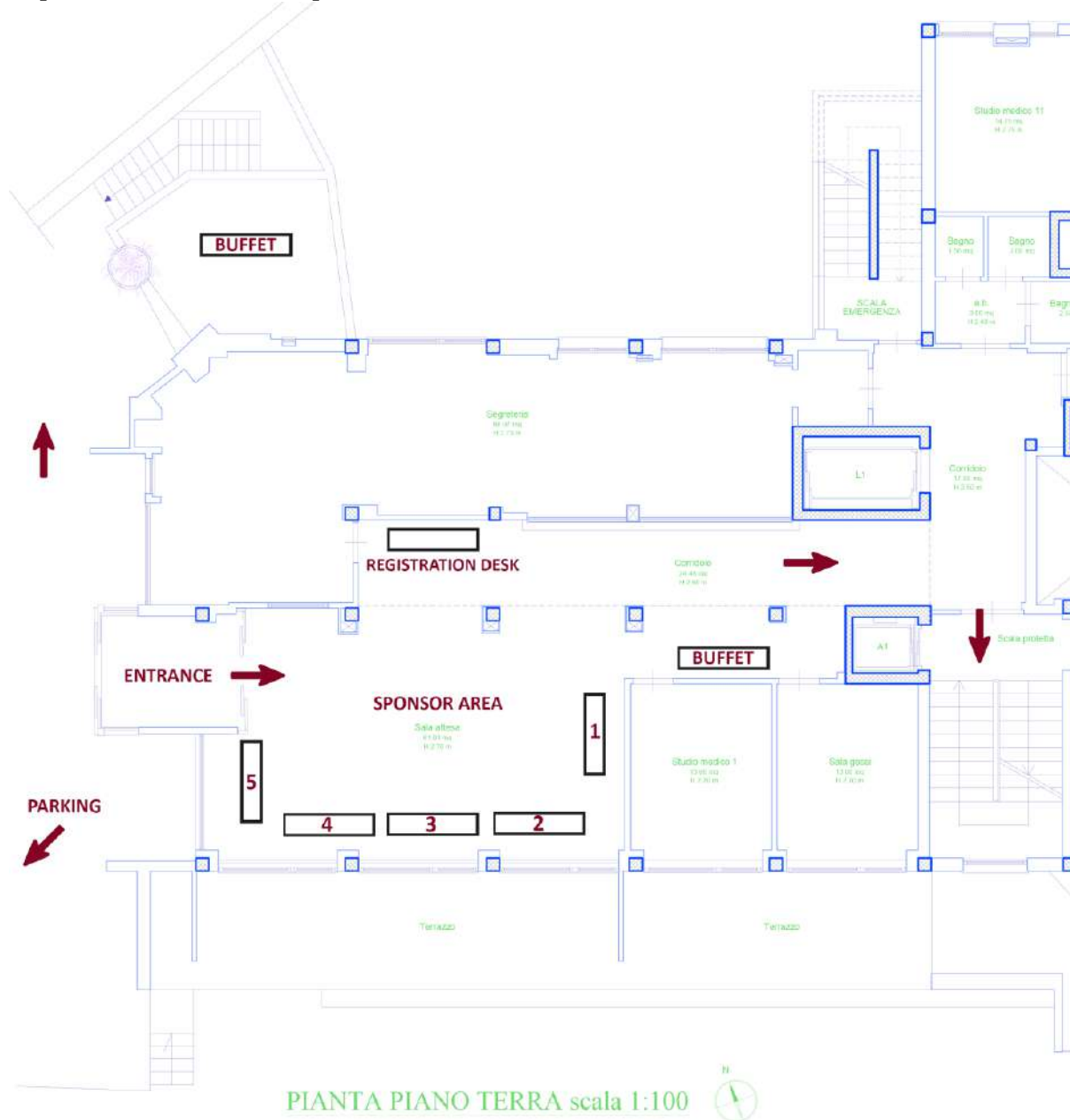

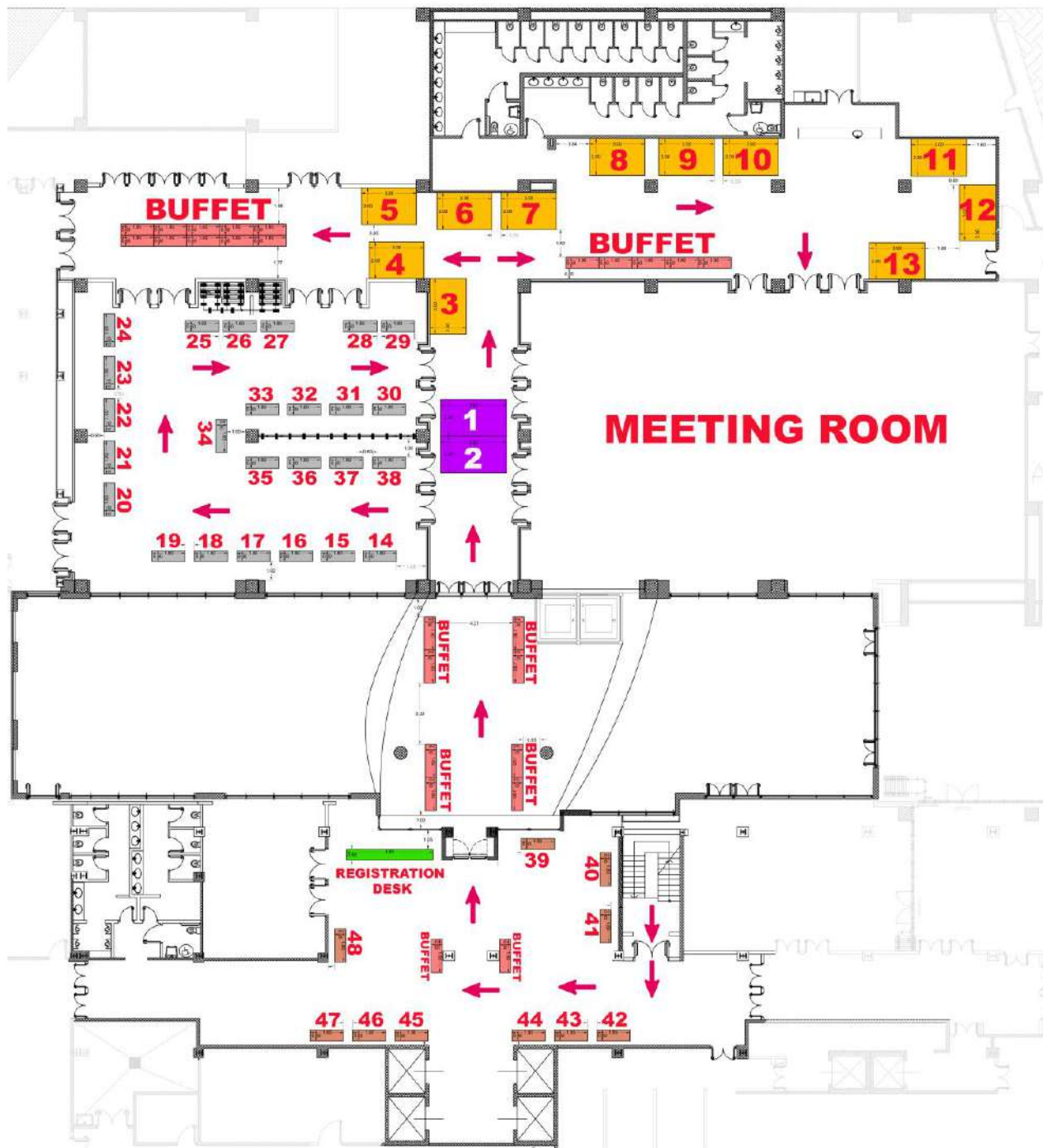

The exhibit program is designed to provide hair transplant surgeons first-hand information about products and services specific to the area of hair restoration surgery and to serve as a forum for sharing current technological advances in the field. The ISHRS seeks companies with ethical and truthful advertising and reserve the right to accept or reject any application to exhibit at its discretion.

### **How this works**

## Products/Services Exhibited
